Ofi Invest Asset Management expands European distribution of its Ofi Invest ISR Actions Japon fund

Ofi Invest Asset Management has announced that its Ofi Invest ISR Actions Japon fund will be distributed in several new European countries. The fund, which has been open to new investors since December 2005, is now available in five new European countries: Portugal, Spain, Italy, Austria and Germany.

This reflects Ofi Invest Asset Management determination to derive greater value out of its flagship capabilities in Europe as part of its strategy to expand sales internationally.

Ofi Invest AM possesses long-standing and well-regarded capability in Japanese equities, with a two-manager team - Jean-François Chambon and Julien Rolland - specialising in this asset class. This strategy has more than 692 million euros in assets under management as of 18 September 2023.


Ofi Invest ISR Actions Japon⁽¹⁾ invests in Japanese equities to help investors tap into that country's economic and social potential and trends over the fund's five-year recommended horizon, while assuming the risk of loss of capital incurred in any investment in equities. The fund's conviction-based strategy selects companies having fundamentals that, in the managers' opinion, are solid and have strong upside potential. As a holder of the official French ISR [SRI] label⁽²⁾, the fund seeks to enhance long-term value while reconciling equity investment with socially responsible engagement.

The fund managers said: "So far this year, the Japanese economy has been surprisingly robust. In the first half, GDP grew in real terms by an annualised 2.4% - especially high for a country whose structural growth is below 1%. The drivers of the Japanese economic engine are now mainly domestic, based on household consumption and business investment, which roared back to life after running into post-Covid difficulties. In the medium term, Japan looks best placed to ride economic development in Southeast Asia and a possible economic recovery in China, with a major local footprint in robotics, among other industries."


